This has reference to your online application bearing registration no EX-00890-819 on the above cited subject and the subsequent report dt: 26.07.2018 received from the inspection committee, constituted for the purpose of periodical inspection of the school.

In this regard, the following deficiencies / requirements have been observed for compliance. The School is required to submit the compliance of the deficiencies / requirements by 31st Dec 2018 :-

1. The school is required to submit Compactness Certificate of land issued/Certified by the Competent Authority (i.e. Registrar/Tehsildar) in the format given at Appendix-VI of Affiliation Bye-Laws. The Affiliation Bye-Laws and land certificate format are available at CBSE website www.cbseaff.nic.in. (Note: Land details should be filed/mentioned as per land papers and proper legible stamp/seal of Competent Authority must be affixed).
2. The school is required to submit copies of renewed certificates of Fire Safety, Building Safety (as per formats (appendix) given in Affiliation Bye-Laws of the Board) duly issued from concerned/competent authority i.e. Fire Department, PWD etc. of the State Government.
3. The school is required to appoint Special Educator as per rule 13 (11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.
4. Enrolment of students in many sections is high. Hence, the school is directed to strictly maintain optimum number of 40 students in each section from session 2019-20 and submit revised list of enrolment class/section wise along-with an affidavit duly attested by 1st Class Magistrate in support of the same.

Further keeping in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto 31.03.2019 along with permission for registration of bonafide candidates of class IX / XI and submission of list of existing candidates of the School for class X and XII for current session.

However, regularization of affiliation from 01.04.2018 for a period of 05 years will be subject to the specific compliance on the discrepancies communicated by the School latest by (date 31st Dec 2018) failing which a penalty of Rs.20,000/- per month will be levied on the school and the process of withdrawal of affiliation may also be initiated.

9.	The number of sections in the school are restricted to 62 as per number of sections reported by the IC and shall not be increased without specific approval of the Board. For increase in number of sections, the School shall apply online to the Board as per rule 15.7 of affiliation bye laws.
10.	The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurred by the Board, if any, arising out of these circumstances.
11. Order No.06 **Date: 03.03.2022**

This case is taken up through video conferencing.

Initially the writ petition was filed on 17th March, 2020 for quashing the order dated 28th February, 2020 (Annexure-30 to the writ petition) passed by the Inspector General of Registration, Jharkhand, Ranchi, whereby the amendment in favour of the respondent no.9 and others was allowed by substituting the executive body, which, according to the petitioner, was of the year 2008-09.

On perusal of the order sheet of this case, it appears that different interim orders were passed, however, no order staying operation of the impugned order dated 28th February, 2020 was passed.

The petitioner has now filed I.A. No.1632 of 2022, seeking stay of the order dated 28th February, 2020 passed by the Inspector General of Registration, Jharkhand, Ranchi and for restraining the respondent no.9 seeking assistance of a magistrate for taking over the charge of the management of the society- Sri Ram Krishna Seva Sangh, Ranchi as well as the school, namely, Vivekananda Vidya Mandir, Sector-2, Dhurwa, Ranchi being run by it, as the State authorities have no jurisdiction to resolve inter se dispute between two factions of the Managing Committee of the society as well as the said school.

Heard learned counsel for the parties on the said interlocutory application. The claim of the petitioner is that the respondent no.10 has issued registration certificate to the Managing Committee led by

the respondent no.9, which, in fact, was constituted in the year 2008-09, whereas the claim of the private respondents including the respondent no.9 is that the election of the Managing Committee was held on 4th February, 2018 and subsequent thereto an application was made before the respondent no.10 for issuance of registration certificate to that effect and on submission of the enquiry report by the Deputy Commissioner, Ranchi, the registration certificate was issued on 28th February, 2020.

Rival contention of the parties requires consideration in detail. However, keeping in view that the interest of students of the said school should not be adversely affected due to claim and counterclaim between two factions of the Managing Committee of the said society, this Court deems it proper to forthwith appoint an Administrator to look after the management of the said society as well as the said school being run by it.

Mr. Manish Kumar, learned counsel for the petitioner and Mr. Mahesh Tewari, learned counsel for the respondent no.9 jointly submit that Hon'ble Mr. Justice Narendra Nath Tiwari (Retired Judge of this Court) may be appointed as an Administrator for the said purpose.

Considering the said submission, Hon'ble Mr. Justice Narendra Nath Tiwari is appointed as an Administrator to look after and manage the affairs of the society as well as the concerned school being run by it.

Mr. Abhay Kumar Mishra, who is representing the petitioner in the present writ petition, is directed to hand over the charge of the said society as well as the school and all other assignments related therewith to the Administrator including the details of the accounts being maintained by the society and the school in all the banks on 7th March, 2022 (forenoon).

The Administrator after taking over the charge may delegate certain powers to any person or persons for his assistance who is/ are not associated with both the factions of the Managing Committee.

The Honorarium to be paid to the Administrator for devoting his time in managing the affairs of the society and the school will be fixed subsequently.
